Legislative Updates: H7 passed and is now on the governor's desk (passed/signed by Governor 2/24/25). \$300 mandatory minimum for 3oz or less of marijuana. H271 sponsored by Rep. Boyle and Rep. Lakey. This is the bill that addresses dispensary advertising making it illegal in Idaho. We sent the Meridian code updates to all Meridian District Representatives and the bill's sponsors. Rep. Boyle said we can testify if we'd like. Staff can only testify as a constituent off the clock. MADC members are welcome to testify. We'll keep an eye on the bill. Testifying is usually a last-minute thing. They do offer remote testimony. (Susie) Would like to know more about testifying. (Caylee) Would like to know more about testifying.
