## 10:30am Training Topic - Patrol, Dispatch, Emergency Access

## Speaker: Cpl. Kevin Kinnaman - Patrol (see attached presentation)

- Shifts (days, swings, graveyards). Officers are working in Meridian 24/7.
- CAD, calls for service.
- Non-emergency dispatch is the best number to call, unless it is a life-threatening emergency or a situation is in progress.
- It is important to put the non-emergency number in your cell phone.
- Always be as descriptive as possible with dispatch. The information you give dispatch will determine the police response. (lights and sirens vs. driving with the flow of traffic).
- Everything is always documented, whether you get a report or not.
- Code enforcement who you want to call if something is diminishing the beauty of Meridian (weeds, cars, graffiti, etc.).
- Community Service Officers (CSO) Takes reports, helps with traffic control, assists
  patrol, no arrest powers, will handle calls that do not have something in progress/there
  is not a known suspect.

# 11:15am Knox Boxes and Hot Topic Updates

- Law enforcement does not have access to Knox Boxes without Fire Department assistance. In a major emergency, this may lead to officers breaching the door.
- Climate-controlled buildings must have a keypad at main entry points to the buildings. Let us know if you need to get this process started for your building.
- We met with an ICE representative. Call Non-Emergency Dispatch if you come across someone providing false identification.

### 10:30am Code Enforcement

- Code Enforcement works with all divisions within the City of Meridian.
- Code Enforcement enforces city ordinances written within Meridian City Code.
- Residential code affects apartments. Code Enforcement needs permission to enter private property.
- When cars are parked blocking a stop sign, it doesn't matter if it is blocking the view, the vehicle only needs to be 30 feet from the stop sign.
- Code Enforcement can get cars towed from apartment complexes, if it is authorized by property management. They can tag the car and after 48 hours, the vehicle can be towed.
- When apartment complexes are under construction, trash receptacles are required to ensure the sites don't create hazards.
- If an offense effects other properties, that is when code enforcement gets involved such as nuisances (example: stagnant water).
- Weeds that are over 8" in height, code enforcement can handle them. Weeds this tall can be a fire hazard.
- For graffiti removal, call non-emergency dispatch, patrol then will forward the call on to Code Enforcement. A 5-day notice for removal is given to the property.
- If there is a porch or balcony facing a public street and the resident is using their porch and balcony for storage, it is not considered junk or a nuisance.

#### 10:30am Crisis Intervention Team

- Crisis Intervention Team 2 police officers, 1 mental health clinician
- What is a crisis? A response to a life stressor, especially when someone's normal coping mechanisms fail. This leads the individual to incorporate dysfunctional behaviors driven by fear, anxiety, and anger.
- CIT responds to mental health calls for service (suicidal subjects. crisis calls, welfare checks, etc.).
- They assess the needs of the individual in crisis and de-escalate the situation.
- They determine if an involuntary hospitalization (mental hold) if required or if a safety plan can be created so the individual can remain in the community while they receive mental health treatment.
- They follow up with those who were placed on a mental hold after they are discharged and those with referrals from department staff and the community.
- All Meridian Police officers are trained to recognize a mental health crisis and how to appropriately respond to mental health calls for service.
- Involuntary Mental Holds: according to Idaho Code 66-326, law enforcement or a physician (with admitting privileges) may place an individual on an involuntary mental hold if the following criteria is met:
  - 1. Danger to self 2. Danger to others 3. Gravely disable as a result of mental illness.

### Indicators of a Mental Health Crisis

- Is a friend or family member starting to isolate themselves?
- Is a friend or family member using drugs and/or alcohol?
- Is a friend or family member self-harming?
- Is a friend or family member experiencing a change in behavior?
- Is a friend or family member talking about suicide?

## Getting Help for a Friend or Family Member in Crisis

- Talk and listen to your friend or family member to learn about their need(s)
- Refer your friend or family member to the Idaho Crisis and Suicide Hotline (988)
- If you get information that your friend or family member is suicidal or has a plan to attempt suicide, call 911.

## **Updates:**

We had a property manager reach out who requested to meet with us about issues
they were having with residents and to conduct a CPTED Security Survey. We were
able to give them tips on how they could improve their property, as well as given
them additional resources the Meridian Police Department has to offer. If you
would like us to come out to your property, feel free to reach out to us.

# 10:30am Ada County Coroner's Office

## Steps taken by the Coroner's Office when someone dies at an apartment complex:

- Secure the apartment
- Document who, when, and how
- Find the Emergency Contact Information but please do not notify
- If there is a key fob or smart lock that logs entry times, that can help narrow down the time of death.
- Does the decedent have a vehicle on the property?
- The Coroner's Office protects all property of the decedent.

#### Next of Kin

- Spouse must be legally married
- Adult children must be biological children
- Parents biological parents, not stepparents
- Siblings Adult biological siblings

#### Unclaimed Decedent

- No legal next of kin or abandoned by next of kin
- Public Administrator Ada County Treasurer's Office is notified of the death.
- Treasurer's Office will take possession of all personal property.
- Remembered with Compassion at Cloverdale Funeral Home

#### Coroner Seal

- We are required to seal property on all scenes where next of kin is absent or unknown. This could be a bedroom, entire residence, and includes vehicles.
- Property must remain sealed and protected until legal next of kin is notified and arrangements can be made.
- If there is blood or other biohazardous materials where the individual died, there are biohazard clean up companies who you can call to clean up the area.

#### **Probate**

• Probate is the court process to transfer titles of property of a decedent to his or her successors and pays any creditors.

#### What if the decedent has a will?

 Probate will be necessary to declare the will to be valid and to appoint the personal representative under the will. The personal representative can then carry out the terms of the will.

#### What if the decedent does not have a will?

 Probate may be required to make a determination of heirs and to appoint a personal representative to handle the estate.



- "It's not what we know, it's what we can prove," regarding investigations.

# Investigation example from your info:



What you might see in your apartment inspections that might indicate suspicious behavior:

- Paraphernalia
- Foil with burn marks
- Pipes
- Baggies
- Locks on outside of doors
- Tools: possible stolen property
- Credit cards in multiple different names
- Different clothing not commonly associated with children in their spaces.
- Video cameras in rooms of residence
- Mattresses on floors
- Animal feces/ unhealthy surroundings

## Obtaining Information and Building Trust:

Remind tenants that the information they provide to you (Manager/Owner) can be valuable to Law Enforcement, and if they relay the information to you that we don't need the specific name of the reporting party.

CONFIDENTIAL INFORMANT: an individual that was once in trouble and working with law enforcement to help the case.

CONFIDENTIAL SOURCE: Where the original information came from (more general).

## Q&A:

- Clarify Dispatch-Non-emergency for normal issue 911 for emergency.
- Q: Is there a way to bridge the gap of communication between calls for service and managers being notified of what's happening at their complex?
  - Certain types of calls can't be shared for privacy reasons.
  - Business card dropped in rent drop regarding police activity reason.
  - MPD Crime Prevention needs accurate property manager contact information, also can reach out to crime prevention for information.
  - MPD is happy to provide resident meetings/ employee training and Security Survey of complex for reference.

- Q & A: continued...
- Meridian Park and Gramercy Villas asked about suspicious activity in their complexes.
- Q: Does "Security" calls count for "multiple calls for service stats/ notifications?"
  - A: There is not a formal "Nuisance Ordinance," however, dispatch does document and can relay to officers responding how many calls for service have been at that address.
  - A: Public 'records request' to Dispatch for CAD records will also tell you number of calls and call types if available.
- Q: Resident who appears to be running possible prostitution out of apartment and children are present?
  - A: Health and Welfare call for service or inquiry
- Q: Resident yelling at everyone in complex?
  - A: Both the above may be mental health of health and Welfare concerns. Calling non-emergency dispatch and explaining that you may have a mental health issue or Health and Welfare concern can start the process.
- Q: Concerns with children, neglect, unsafe living environments?
  - A: Utilizing our SRO's (School resource Officers) and the Health and welfare reporting system can help to build a relationship with those kids who will trust the SRO and ultimately confide in them with what's going on at home.
